### **Call to Order by Town Clerk**

The annual Town Hall meeting of Mount Vernon Township was called to order by Clerk LeMay at 6:01 P.M.

Township voters present: Nicholas LeMay, Kip Bauer, Kenny Hayes, Jerome Tobin, Wilburn Warner, Paul Rostollan.

### **Election of Moderator**

Jerome Tobin made a motion to nominate Kenny Hayes as moderator. Wilburn Warner seconded the motion. All voted in favor.

### **Administration of Oath to Moderator by Town Clerk**

Clerk LeMay administered the Oath of Office for the Moderator of The Annual Town Hall Meeting to Kenny Hayes. Hayes assumed the role of moderator for the meeting.

### **Reading of the Minutes of the last Annual Town Meeting (April 11, 2023)**
