

Mount Vernon Township – Minutes

Regular Meeting – July 7, 2025 – 4:00 P.M.
Mount Vernon Town Hall – 811 Harrison Street, Mount Vernon, Illinois

The regularly scheduled monthly meeting of Mount Vernon Township was called to order by Supervisor Amanda Bean at 4:00 p.m.

Township elected officials present were Supervisor Amanda Bean, Clerk Nick LeMay, as well as Trustees Chris Braden, Charlie Heck, Jason Hulbert and Korey Stover. Absent: Assessor Kip Bauer, Road Commissioner Kenny Hayes.

Supervisor Bean reminded those in attendance that T.O.I. will be having a regional meeting at the Mount Vernon Outland Airport July 24th from 6:00 – 8:00 P.M. This will be in conjunction with the Jefferson County Township Officials meeting. Everyone is welcome and encouraged to attend. Contact Amanda or Carrie to register.

The T.O.I.P.A.C annual golf outing in Springfield is scheduled for August 22, 2025, at the Lincoln Greens Golf Course in Springfield. Anyone interested in registering or volunteering may contact Amanda for further details.

Trustee Braden made a motion to approve the minutes from the June 2025, regular meeting. Trustee Stover seconded. All present voted in favor. The motion carried.

The Trustees reviewed the budget vs. actual spending/bills.

Following said review Trustee Heck made a motion to approve the audit of the Township Road bills. Trustee Hulbert seconded. All present voted in favor. The motion carried.

Trustee Stover made a motion to approve the Town bills as presented - subject to audit. Trustee Heck seconded. All present voted in favor. The motion carried.

The Clerk attested to all signatures.

Old Business

Supervisor Bean gave the board an update on the Town Hall building exterior wall repairs to fix the underlying damage and rot, seal and cover the frame with a new exterior wall façade. Homer Mast will be conducting that work in the 3rd week of July and is expected to complete the job in roughly three weeks. The board previously approved \$8,250.00 plus supplies to Mr. Mast for this work to be conducted.

New Business

Supervisor Bean requested that the board discuss a policy soon related to Mount Vernon Township employees who are on Township health insurance when they become eligible for the federal Medicare program. Currently there is no formal policy or procedure in place. The board agreed to discuss this in the near future as an agenda item. Trustee Stover made a motion to discuss and set an employee Medicare/Insurance policy soon, Trustee Braden seconded. All present voted in favor. The motion carried.

Commissioner Hayes requested approval to place a Barber Green asphalt paver on Purplewave.com for public auction when the other previously approved Township items are auctioned. Trustee Heck made a motion to move to approve the sell, Trustee Hulbert seconded. All present voted in favor. The motion carried.

At the request of the board the August meeting date is proposed to be rescheduled for August 4, 2025, so that more board members can attend (scheduling conflicts.) Trustee Heck made a motion to set the August meeting date on August 4, 2025, at 4:00 p.m., Trustee Stover seconded the motion to reschedule. All present voted in favor. The motion carried.

Adjournment

Being no further business for discussion Trustee Heck made a motion to adjourn at 4:43 p.m. Trustee Stover seconded the motion. All present voted in favor. The meeting was adjourned.
